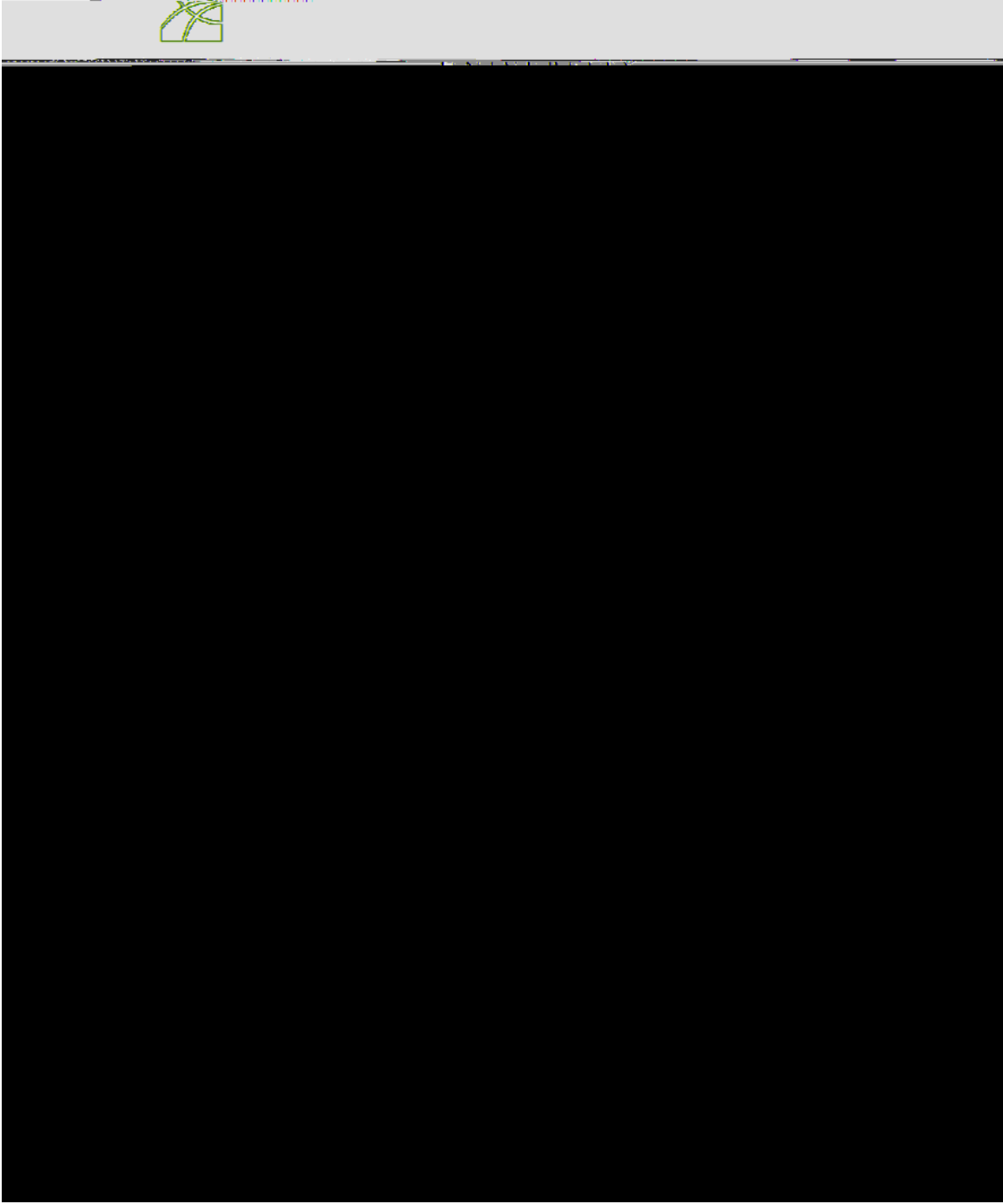

Tara, I would like to further discuss the Faculty Alliance next time.

Thank you for your advice to UA governance and commitment to the shared vision of the University. The Summit Team is composed of a broad set of university employees (Chancellors, vice Presidents) and a small group of faculty (VCAS). This group serves as an advisory group to me on issues that affect them all.

I value governance a great deal and have enlisted faculty governance in a variety of advisory capacities. For example, faculty, staff, and student governance are all part of the internal group received de facto membership on every team; not provosts. I also meet personally with you on a monthly basis and participate in Faculty Alliance retreats, regular meetings, and events. The Faculty Alliance is represented by an officer of the University's executive council, the Statewide Academic Council (SAC). At the same time that I think it is important for me to seek and receive Faculty Alliance input separate from the Provosts or Chancellors, I believe I need the same from the

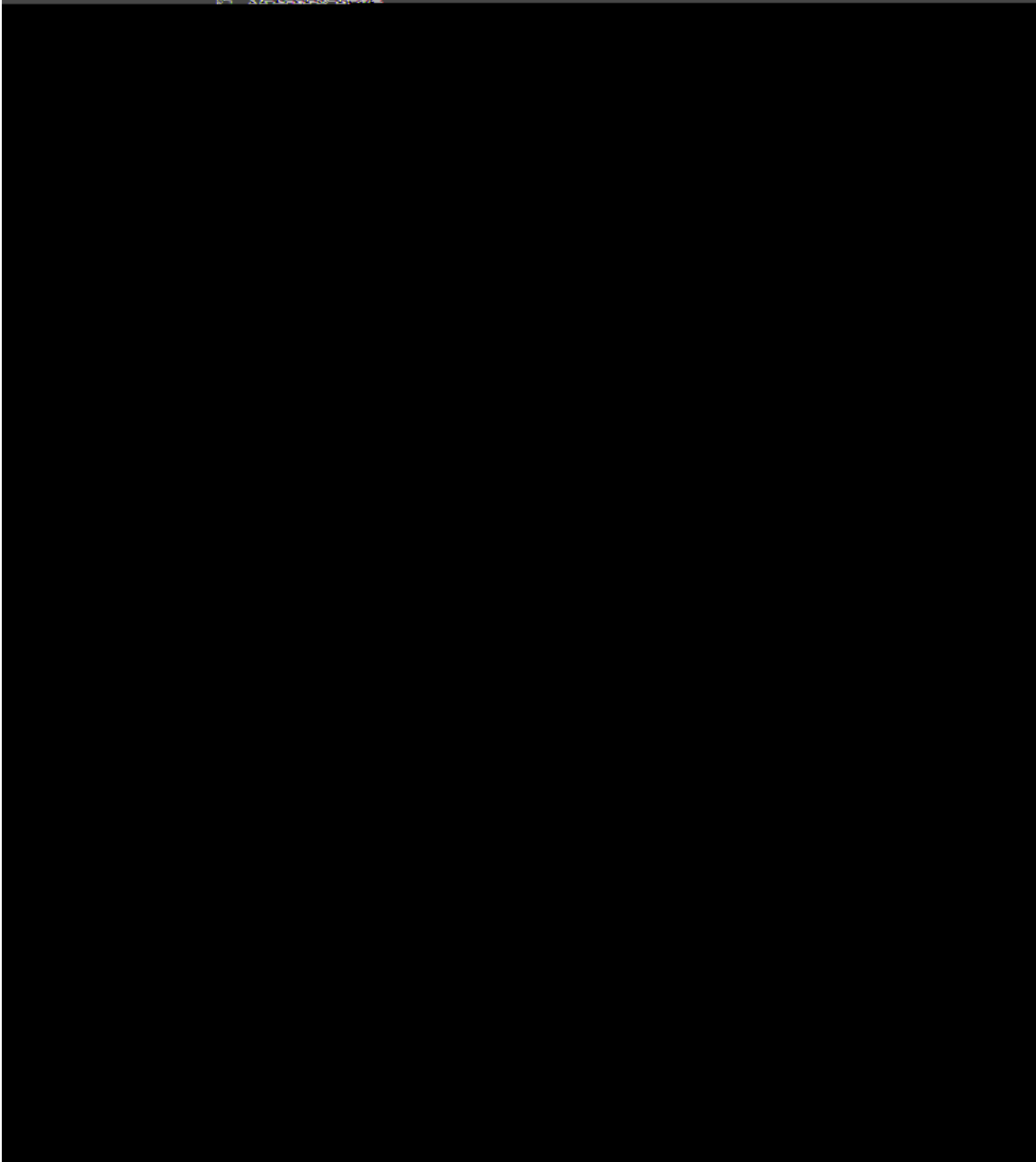
